**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH C&N CONTRACTORS, INC. FOR THE CENTENNIAL PARK ADA COMPLIANT RESTROOM PROJECT**

**WHEREAS**, the Montgomery County Community Development Block Grant (CDBG) has awarded Englewood a grant for \$75,000 for the construction of a new ADA compliant restroom facility at Centennial Park; and

**WHEREAS**, the City of Englewood has entered into a contract with Montgomery County Commissioners for the project; and

**WHEREAS**, a solicitation for bids was publicly advertised for the Centennial Park ADA Compliant Restroom Project; and

**WHEREAS**, four bids were received, publicly opened, and read aloud at 12:00 noon, March 18, 2016, at the Englewood Government Center; and

**WHEREAS**, a tabulation of the bids received was forwarded to the CDBG for approval.


**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I**                      That the City Manager is hereby authorized to execute a contract with C&N Contractors, Inc., 1203 W. Main Street, Springfield, Ohio 45504, in an amount not to exceed three-hundred ten thousand dollars and no cents (\$310,000.00).






