A RESOLUTION: AUTHORIZING THE CITY MANAGER TO AMEND A PURCHASE AGREEMENT WITH SEDIMENT REMOVAL SOLUTIONS

WHEREAS, the City Manager entered into a \$44,600.00 purchase agreement on January 31, 2017 with Sediment Removal Solutions to remove organic sediment from the pond at Centennial Park; and

WHEREAS, the purchase agreement was based upon reasonable estimates of organic sediment volume and the number of days required to remove it; and

WHEREAS, the purchase agreement needs to be increased due to the volume of sediment discovered and the number of days required to remove it, which could not have been reasonably anticipated at the time of the initial purchase agreement; and

WHEREAS, Section 232.10 contains formal bidding and Council authorization provisions for contracts exceeding \$50,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, OHIO AS FOLLOWS:

SECTION I That the City Manager is hereby authorized and directed to amend the January 31, 2017 purchase agreement with Sediment Removal Solutions of Ohio, 15318 Pusheta Road, Wapakoneta, OH 45895, to an amount not to exceed \$56,600.00 (Fifty-Six Thousand, Six Hundred Dollars).

SECTION II It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION III

That this Resolution shall be in full force and effect at the earliest date allowed by law.
