**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO PURCHASE  
REPLACEMENT EQUIPMENT FOR THE WASTEWATER  
TREATMENT PLANT (WWTP)**

**WHEREAS**, the efficient operation of the WWTP is necessary to meet environmental objectives including EPA discharge mandates; and

**WHEREAS**, the Englewood WWTP is forty-two years old and certain equipment has exceeded its useful design life in terms of both technology and deterioration; and

**WHEREAS**, the WWTP is ready for a major overhaul to ensure efficiency, reliability and a safe, productive work environment.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ENGLEWOOD, OHIO AS FOLLOWS:**

**SECTION I**            That the City Manager is hereby authorized to purchase various pieces of new and replacement equipment services for the raw screen building of the WWTP from various suppliers including the Duperon Company at a cost not to exceed Two Hundred and Ninety Thousand dollars (\$290,000).

**SECTION II**          That the City Manager is hereby authorized to purchase equipment/services from various suppliers including the Duron UV System from Wedeco Manufacturing at a cost not to exceed Two Hundred Thousand dollars (\$200,000).


**SECTION III**        That this purchase is in compliance with Section 232.10(N) of the Englewood Codified Ordinances that provides for the purchase of unique or custom equipment or a specialty item.

**SECTION IV**






