**AN ORDINANCE: PROVIDING FOR THE LEVYING OF ASSESSMENTS RELATED TO
THE REPAIR/REPLACEMENT OF SIDEWALKS, CURBS AND
DRIVE APRONS PURSUANT TO AN AUTHORIZED ENGLEWOOD
“2014 SIDEWALK PROGRAM”**

WHEREAS, Englewood has regularly authorized annual, neighborhood-oriented programs for the repair and replacement of sidewalks, curbs and drive aprons; and

WHEREAS, estimated costs for such repairs have been announced to property owners in advance of work being done, and property owners have been offered the opportunity to effect repairs before work designated has been accomplished by the city; and

WHEREAS, property owners have been offered the opportunity to pay the costs of such repairs, having been given a minimum of thirty(30) days to do so, before such costs have been prepared for certification to Montgomery County for collection with taxes;

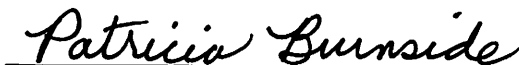
NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, COUNTY OF MONTGOMERY, STATE OF OHIO, AS FOLLOWS:

SECTION I That direct costs incurred by the city in conjunction with the authorized 2014 sidewalk, curb and driveway apron repair/replacement programs, and not repaid by benefited property owners, be certified by the Director of Finance to the Montgomery County Auditor, for collection in five equal installments, said amounts to be placed on the tax duplicates of affected properties and collected in the same manner as other taxes, and as provided by law.

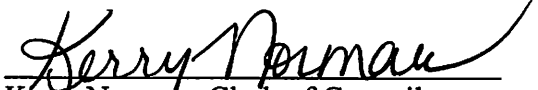
SECTION II It is hereby found and determined that all formal actions of this council concerning and relating to the passage of this ordinance were taken in open meetings of this council, and that all deliberations of this council, and of any committees, that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements.

SECTION III That this ordinance shall be in full force and effect at the earliest date allowed by law.

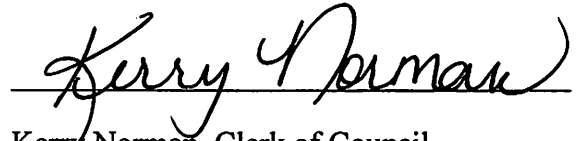

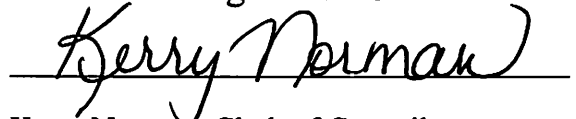
