**A RESOLUTION: APPROVING THE CHARGES ASSESSED AND COLLECTED FOR RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL**

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I** For service provided from April 1, 2018 to March 30, 2019, the monthly charges for residential refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Single family residence including curbside recycling	\$12.75
Surcharge for Carryout Service	\$12.00
Surcharge for Toter Service	\$ 3.00
Multi-family residential dumpster service, with recycling	\$44.00

**SECTION II** For service provided from April 1, 2019 to March 30, 2020, the monthly charges for residential refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Single family residence including curbside recycling	\$13.35
Surcharge for Carryout Service	\$12.00
Surcharge for Toter Service	\$ 3.00
Multi-family residential dumpster service, with recycling	\$44.00

**SECTION III** For service provided from April 1, 2020 to March 30, 2021, the monthly charges for residential refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Single family residence including curbside recycling	\$13.97
Surcharge for Carryout Service	\$12.00
Surcharge for Toter Service	\$ 3.00
Multi-family residential dumpster service, with recycling	\$44.00

**SECTION IV** Collection for the monthly charges for refuse collection as approved above shall be made on a bimonthly basis from all residences receiving service

as provided for in Chapter 1064 of the Codified Ordinances of Englewood, Ohio.

**SECTION V** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION VI** That this Resolution shall be in full force and effect at the earliest date allowed by law.
