**A RESOLUTION: APPROVING THE PURCHASE OF TWO (2) DUMP  
TRUCK/SNOW PLOWS AND ASSOCIATED EQUIPMENT**

**WHEREAS**, two 15 year old dump truck/snow plows have exceeded their useful life and need to be replaced.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ENGLEWOOD, OHIO AS FOLLOWS:**

**SECTION I**            That the purchase of two (2) dump truck chassis is hereby approved at a cost not to exceed \$161,902 from Stoops Freightliner, 7800 Center Point 70 Blvd., Dayton, Ohio 45424 (937-236-4092).

**SECTION II**            That the purchase of two (2) sets of accessory equipment for the above mentioned chassis is hereby approved at a cost not to exceed \$180,000 from Henderson Products, S.R. 19, Bucyrus, Ohio, 44820 (419-617-7509), such equipment includes snow plow hitch, hydraulic system, salt spreader and the associated support equipment.

**SECTION III**            That those items have all been pre-bid through the Ohio Department of Administrative Services or the National Joint Powers Alliance.

**SECTION IV**            It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in


those formal actions were in meetings open to the public, in compliance with all legal requirements.




