**A RESOLUTION: AUTHORIZING A CONTRACT WITH SMOLEN ENGINEERING, LTD. FOR THE STILLWATER BIKEWAY BRIDGE PROJECT (PID 99981)**

**WHEREAS,** Englewood has agreed to be responsible as the lead agency and participate with Five Rivers Metroparks and others to construct a historic pedestrian covered bridge across the Stillwater River along the Old National Road; and

**WHEREAS,** the Miami Valley Regional Planning Commission has approved a 2.2 million dollar grant towards construction of the bridge and connecting trails; and

**WHEREAS,** a contract with the Ohio Department of Transportation dated July 14, 2015 has been executed; and

**WHEREAS,** a great deal of preliminary engineering must take place in the form of environmental analysis, subsurface investigation, site survey, design and drawings.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, OHIO AS FOLLOWS:**

**SECTION I**                      That the City Manager is hereby authorized to execute an agreement with Smolen Engineering, LTD., 1876 State Route 46 North, Jefferson, Ohio 44047 at a cost not to exceed two hundred and ninety thousand dollars (\$290,000)

**SECTION II**                      It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.


SECTION III

That this Resolution shall be in full force and effect at the earliest date allowed by law.
