**AN ORDINANCE: AMENDING SECTION 220.02(A) OF THE ENGLEWOOD
CODIFIED ORDINANCES, ENTITLED “REGULAR
MEETINGS.”**

WHEREAS, Section 2.06(a) of the Charter of the City of Englewood establishes a minimum requirement that the City Council “meet regularly at least once in every month as prescribed by its rules”; and

WHEREAS, the City has enacted Section 220.02(a) of the Codified Ordinances of Englewood, which requires the City Council to meet “every second and fourth Tuesday of each month at 7:30 p.m., except in July and August, in which months there shall be one meeting, on the second Tuesday of such months”; and

WHEREAS, the City Council has determined that it would be in the best interests of the City to amend Section 220.02(a) to provide greater flexibility regarding the scheduling of regular meetings to provide for the efficient and expedient consideration of Council’s business; and

WHEREAS, the City is authorized as a charter municipality to exercise all powers of local self-government.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:

SECTION I Section 220.02(a), is hereby amended as follows:

Section 220.02(a) is hereby amended to provide as follows in its entirety:

220.02 MEETINGS.

- (a) Regular Meetings. Meetings shall be held every second and fourth Tuesday of each month at 7:30 p.m. Whenever appropriate, the Mayor may cancel one regular meeting per month.

SECTION II All provisions of Chapter 220 not specifically amended herein, including Sections 220.02(b) through (j), shall remain the same.

SECTION III That this Ordinance shall become effective at the earliest date allowed by law.

SECTION IV It is hereby found and determined that all formal actions of this City Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.




