**A RESOLUTION: Authorizing the City Manager to Purchase a Fully Equipped Snow Plow/Dump Truck**

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, OHIO AS FOLLOWS:**

**SECTION I**            That the purchase of Freightliner M2-106 cab and chasis from Stoops Freightliner at a cost not to exceed eighty two thousand dollars (\$82,000) is hereby approved.

**SECTION II**            That the purchase of a snow plow, dump body, hydraulics, hoist, spreader, electrical system, pre-wet system, wing plow, and miscellaneous accessories from Henderson Products at a cost not to exceed ninety one thousand dollars (\$91,000) is hereby approved.

**SECTION III**            That the purchase of a central control hydraulic control system from Peak Electric, Inc. at a cost not to exceed twenty thousand dollars (\$20,000) is hereby approved.


**SECTION IV**            That this equipment has been pre-bid through the State of Ohio Cooperative Purchasing Program and/or the National Joint Powers Alliance (NJPA).

**SECTION V**            It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION VI

That this Resolution shall be in full force and effect at the earliest date allowed by law.




