A RESOLUTION: PLEDGING TO NAME THE HISTORIC NATIONAL ROAD COVERED BRIDGE IN MEMORIAM OF EDWARD S. KEMPER

WHEREAS, former 18-year Mayor Edward S. Kemper had an inexhaustible zeal for community service, leadership and hard work, including the establishment of the Englewood Sister City Club; and

WHEREAS, Ed was both an avid supporter of the City of Englewood and a founding member and past president of the Ohio National Road Association; and

WHEREAS, the City of Englewood wishes to honor the memory of Ed in a meaningful and reverential manner.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:

SECTION I: That the Englewood City Council hereby pledges that upon the completion of the Historic National Road Covered Bridge, a dedication and naming ceremony will be arranged, at which time the National Road Covered Bridge will henceforth be named in memoriam of Edward S. Kemper and will be known as the "Edward S. Kemper National Road Covered Bridge."




