A RESOLUTION: DECLARING THE OFFICIAL INTENT AND REASONABLE EXPECTATION OF THE CITY OF ENGLEWOOD, OHIO ON BEHALF OF THE STATE OF OHIO (THE BORROWER) TO REIMBURSE ITS RESERVE FOR WATER IMPROVEMENTS FUND FOR THE BROWNSTONE DRIVE WATER MAIN REPLACEMENT PROJECT (CD18U/CD19U), HEATHER STREET WATER MAIN REPLACEMENT PROJECT (CD28U/CD29U), AND GLENMARY AVENUE WATER MAIN REPLACEMENT PROJECT (CD13U/CD14U) WITH THE PROCEEDS OF TAX-EXEMPT DEBT OF THE STATE OF OHIO.

WHEREAS, a declaration of official intent is required by a local subdivision seeking reimbursement from the Ohio Public Works Commission for project costs incurred and paid by the subdivision.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, OHIO, ON BEHALF OF THE STATE OF OHIO AS FOLLOWS:

SECTION I That the City of Englewood reasonably expects to receive a reimbursement for the Brownstone Drive, Heather Street, and Glenmary Avenue Water Main Replacement Projects as set forth in Appendix A of the Project Agreements with the proceeds of bonds to be issued by the State of Ohio.

SECTION II That the maximum aggregate principal amount of bonds, other than for costs of issuance, expected to be issued by the State of Ohio for reimbursement to the local subdivision is one hundred ninety-seven thousand, eight hundred three dollars (\$197,803) for the Brownstone Drive Water Main Replacement Project; one hundred forty-three thousand, six hundred ninety-two dollars (\$143,692) for the Heather Street Water Main Replacement Project; and one hundred ninety-eight thousand, seven hundred ninety-five dollars (\$198,795) for the Glenmary Avenue Water Main Replacement Project.

SECTION III That the Clerk of Council of the City of Englewood is hereby directed to file a copy of this Resolution with this city for the

inspection and examination of all persons interested therein and to deliver a copy of this Resolution to the Ohio Public Works Commission.

SECTION IV

It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.


SECTION V




