AN ORDINANCE: AMENDING SECTION 1044.10, CHARGES FOR WATER SUPPLIED WITHIN THE CITY; SECTION 1044.11, CHARGES FOR WATER SUPPLIED OUTSIDE THE CITY; SECTION 1044.12, CHARGE FOR WATER SUPPLIED TO CONTAINERS; SECTION 1052.11, CHARGES FOR SEWER SERVICE WITHIN THE CITY; AND SECTION 1052.12, CHARGES FOR SEWER SERVICE OUTSIDE THE CITY, OF THE CODIFIED ORDINANCES OF ENGLEWOOD, OHIO, 1972, AS AMENDED

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, OHIO, AS FOLLOWS:

SECTION I That Section 1044.10: **CHARGES FOR WATER SUPPLIED WITHIN THE CITY**, of the Codified Ordinances of Englewood, Ohio, 1972, as amended, is hereby amended to read as follows:

1044.10 CHARGES FOR WATER SUPPLIED WITHIN THE CITY

Each consumer or owner whose premises within the City is connected to the water system shall pay to the City for the connection and for water at the rate of not less than ~~fifteen~~ **sixteen** ~~dollars and fifty-five~~ **thirty cents (\$15.55 16.30)** bimonthly for each dwelling, commercial, manufacturing or other unit served, plus ~~three dollars and eleven~~ **twenty-six cents (\$3.11 3.26)** per 1,000 gallons of water delivered bimonthly over 5,000 gallons for each such unit served.

SECTION II That Section 1044.11: **CHARGES FOR WATER SUPPLIED OUTSIDE THE CITY**, of the Codified Ordinances of Englewood, Ohio, 1972, as amended, is hereby amended to read as follows:

1044.11 CHARGES FOR WATER SUPPLIED OUTSIDE THE CITY

Each consumer or owner whose premises outside the City is connected to the water system shall pay to the City for the connection and for water at the rate of not less than ~~twenty-three~~ **four dollars and thirty-five** ~~forty-five cents~~ (~~\$23.35~~ **24.45**) bimonthly for each dwelling, commercial, manufacturing or other unit served, plus **four** ~~dollars and sixty-seven~~ **eighty-nine cents** (~~\$4.67~~ **4.89**) per 1,000 gallons of water delivered bimonthly over 5,000 gallons for each such unit served.

SECTION III

That Section 1044.12: **CHARGES FOR WATER SUPPLIED TO CONTAINERS**, of the Codified Ordinances of Englewood, Ohio, 1972, as amended, is hereby amended to read as follows:

1044.12 CHARGES FOR WATER SUPPLIED TO CONTAINERS

For water delivered to containers directly from the water system, the purchaser shall pay a charge to the City at the rate of ~~seven~~ **eight** ~~dollars~~ (~~\$7.00~~ **8.00**) per 1,000 gallons with a ~~fifteen~~ **twenty dollar** (~~\$15.00~~ **20.00**) minimum before such water is delivered.

SECTION IV

That Section 1052.11, **CHARGES FOR SEWER SERVICE WITHIN THE CITY**, of the Codified Ordinances of Englewood, Ohio, 1972, as amended, is hereby amended to read as follows:

1052.11 CHARGES FOR SEWER SERVICE WITHIN THE CITY

- (a) Each consumer or owner whose premises within the City is connected to the sewer system shall pay to the City for the connection and for sewer service at the rate of not less than ~~seventeen~~ **dollars and seventeen** ~~eighty cents~~ (~~\$17.17~~ **17.80**) bimonthly for each dwelling, commercial, manufacturing or other unit served, plus **three dollars and forty-three** ~~fifty-six cents~~ (~~\$3.43~~ **3.56**) per 1,000 gallons of water delivered bimonthly over 5,000 gallons for each such unit served.
- (b) Each consumer or owner whose premises within the City is connected to the sewer system but not the water system shall pay to the City for the connection and for sewer service at the flat rate of ~~fifty-one~~ **three dollars and fifty** ~~forty cents~~ (~~\$51.50~~ **53.40**) bimonthly for each unit served.

SECTION V

That Section 1052.12, **CHARGES FOR SEWER SERVICE OUTSIDE THE CITY**, of the Codified Ordinances of Englewood, Ohio, 1972, as amended, is hereby amended to read as follows:

1052.12 CHARGES FOR SEWER SERVICE OUTSIDE THE CITY

Each consumer or owner whose premises outside the City is connected to the sewer system shall pay to the City for the connection and for sewer service at the rate of not less than ~~twenty-five six dollars and seventy-eight cents (\$~~25.78~~ 26.70)~~ bimonthly for each dwelling, commercial, manufacturing or other unit served, plus ~~five dollars and sixteen thirty-four cents (\$~~5.16~~ 5.34)~~ per 1,000 gallons of water delivered bimonthly over 5,000 gallons for each such unit served.


SECTION VI That all prior ordinances in conflict herewith are hereby repealed.

SECTION VII It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION VIII That this ordinance shall be in full force and effect at the earliest date allowed by law and shall be implemented on all utility bills generated after February 1, 2016.
