**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO EXTEND A 2006 CONTRACT FOR WEEKLY REFUSE COLLECTION AND DISPOSAL SERVICES, AND TO EXTEND AN AGREEMENT FOR WASTE REMOVAL AND LANDFILL SERVICE FOR THE WASTEWATER TREATMENT PLANT, WITH RUMPKE OF OHIO, INC.**

**WHEREAS**, a request for bids to provide weekly refuse collection and disposal services was advertised in the Dayton Daily News on Monday, September 25, 2006; and

**WHEREAS**, three (3) sealed bids were received and opened publicly on Wednesday, October, 25, 2006; and

**WHEREAS**, Rumpke of Ohio, Inc. (Rumpke) was subsequently awarded a one-year contract, commencing April 1, 2007, with four annual options for renewal through March 31, 2012; and

**WHEREAS**, Rumpke has previously agreed to hold the contract price for six (6) additional 12-month terms commencing April 1, 2012 and ending March 31, 2018; and

**WHEREAS**, the City has negotiated a 36-month contract extension to include a 4% rate increase per unit, per month effective April 1, 2018; an additional 5% rate increase per unit, per month effective April 1, 2019; and an additional 5% rate increase per unit, per month effective April 1, 2020; and

**WHEREAS**, Rumpke further agreed to extend a proposal dated July 2, 2015 for waste removal and landfill service for the wastewater treatment plant, and has agreed to hold the contract price through March 31, 2021;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I**

That the City Manager is hereby authorized and directed to extend a contract for weekly refuse and disposal services with **Rumpke of Ohio, Inc., 10795 Hughes Road, Cincinnati, OH 45251**, pursuant to the negotiated terms and specifications, for an additional 36-month period beginning April 1, 2018 and ending March 31, 2021.

SECTION II

That the City Manager is further authorized and directed to continue an agreement for waste removal and landfill service for the wastewater treatment plant with **Rumpke of Ohio, Inc., 10795 Hughes Road, Cincinnati, OH 45251**, pursuant to the terms and conditions contained in a July 2, 2015 proposal, at a cost not to exceed one hundred fifty thousand dollars (\$150,000.00) annually.


SECTION III

It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.


SECTION IV

That this Resolution shall be in full force and effect at the earliest date allowed by law.




