A RESOLUTION: AUTHORIZING THE CITY MANAGER TO PURCHASE NEW BODY WORN CAMERA (BWC) AND IN-CAR CAMERA SYSTEMS FOR THE ENGLEWOOD POLICE DEPARTMENT

WHEREAS, the Englewood Police Department has been utilizing in-car cameras and BWC for many years, and

WHEREAS, the existing in-car camera and BWC systems have become unreliable due to manufacturer defects and flawed technology, and

WHEREAS, the in-car cameras and BWC's have been proven to be essential to the operation of the police department and the need for reliable, clear videos is critical, and

WHEREAS, the police department, in coordination with the IT department, has fully researched and tested camera systems, and

WHEREAS, the recommended vendor, WatchGuard Video, is the leading provider of mobile video solutions for law enforcement, having supplied in-car video systems and BWC cameras to approximately one-third of all law enforcement agencies in the United States and Canada.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO AS FOLLOWS:

SECTION I: That the City Manager is hereby authorized to purchase from WatchGuard; eight (8) in-car video systems, twenty (20) BWC cameras, one (1) cloud based video virtual server, licenses and fees for a total of approximately Eighty Thousand Dollars (\$80,000).

SECTION III: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.

SECTION IV: That this Resolution shall be in full force and effect at the earliest date allowed by law.
