**AN ORDINANCE: TO LEVY A PERMISSIVE MOTOR VEHICLE LICENSE TAX
PURSUANT TO OHIO REVISED CODE SECTION 4504.173.**

WHEREAS, pursuant to Ohio Revised Code Section 4504.173 effective July 3, 2019, the legislative authority of a municipal corporation may levy an annual license tax upon the operation of motor vehicles on the public roads and highways in that municipal corporation for any authorized purpose; and

WHEREAS, the city of Englewood has authority as a charter municipality to exercise all powers of local self-government; and

WHEREAS, the City Council has determined that it would be in the best interests of the City to levy an annual license tax on the operation of motor vehicles within the municipal corporation as permitted by Ohio Revised Code Section 4504.173.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

SECTION I.

There is hereby levied an annual license tax upon the operation of motor vehicles on the public roads and highways of the city of Englewood, Ohio, pursuant to Section 4504.173 of the Ohio Revised Code, for the purposes of planning, constructing, improving, maintaining, and repairing public roads, highways, and streets, and to provide additional revenue for the purposes authorized by Section 4504.173(A)(2) of the Ohio Revised Code, and to supplement revenues already available for such purposes.

SECTION II.

The license tax referenced above in Section I shall be at the rate of Five Dollars (\$5.00) per motor vehicle per year, on each and every motor vehicle the district of registration of which, as defined in Section 4503.10 of the Ohio Revised Code, is in the city of Englewood, Ohio; subject to reductions in the manner provided in Section 4503.11 of the Ohio Revised Code and subject to exemptions provided in Sections 4503.16, 4503.17, 4503.172, 4503.173, 4503.18, 4503.41, 4503.43, 4503.46, and 4503.571 of the Ohio Revised Code.

SECTION III.

As used in this ordinance, the term "motor vehicle" shall include all vehicles so defined in Sections 4501.01 and 4505.01 of the Ohio Revised Code.

SECTION IV.

The annual tax imposed by this ordinance shall apply to and be in effect for the registration year commencing January 1, 2020, and shall continue in effect and application during each registration year thereafter.

SECTION V.

The annual tax imposed by this ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio, or to a Deputy Registrar, at the time application for registration of a motor vehicle is made as provided in Section 4503.01 of the Ohio Revised Code.

SECTION VI.

All revenues derived from the annual tax levied herein shall be used by the city of Englewood for the purposes specified in this ordinance, or any other purpose authorized by state law.


SECTION VII.

SECTION VIII.

As required by Section 4504.173(B)(1), this ordinance is not adopted as an emergency measure, and shall be and remain in force from and after the earliest date permitted by law.


