AN ORDINANCE: AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION TO PARTICIPATE IN THE RESURFACING OF STATE ROUTE 49 (PID #103420) AND DECLARING AN EMERGENCY

WHEREAS, the City of Englewood has determined the need for the described project: *Milling and resurfacing of the roadway on State Route 49, Straight Line Mile 7.87 to 8.16, more or less; and*

WHEREAS, the ODOT funding portion is 100% and the local share is 0%

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:

SECTION I Being in the public interest, the City of Englewood gives consent to the Director of Transportation to complete the above described project.

SECTION II The City of Englewood shall cooperate with the Director of Transportation in the above described project. The State shall assume and bear 100% of all of the cost for the Resurfacing of State Route 49 requested by the City and agreed to by the State.

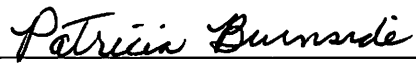
SECTION III That the City Manager is hereby authorized to enter into the attached contract, be and made part hereof, with the Director of Transportation which is necessary to complete the above described project.

SECTION V It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.

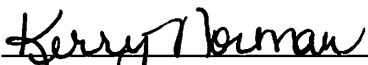
SECTION VI

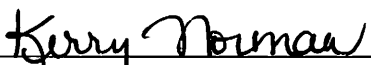
