**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO CONTINUE A PROFESSIONAL SERVICE AGREEMENT WITH RISNER TREE SERVICES IN AN AMOUNT UP TO \$200,000 ON A FEE FOR SERVICE PLAN DURING FISCAL YEAR 2020**

**WHEREAS**, the City of Englewood retains various respected firms to provide professional engineering, legal, consulting, and technical support services; and

**WHEREAS**, Section 232.10(a)(3) of the Codified Ordinances exempts professional services from the requirements of formal bidding; and

**WHEREAS**, Section 232.10(b)(3) of the Codified Ordinances requires Council authorization for the purchase of goods or services at a cost of fifty thousand dollars (\$50,000) or more;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

<b>SECTION I</b>	That the City Manager is hereby authorized to continue a fee for service agreement with Risner's Tree Service for various services at an annual cost anticipated to be up to two hundred thousand dollars (\$200,000).
<b>SECTION II</b>	It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.
<b>SECTION III</b>	That this Resolution shall be in full force and effect at the earliest date allowed by law.
