**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH MOTOROLA SOLUTIONS FOR THE PURCHASE OF THE PREMIERONE SUITE OF SOFTWARE AND CALLWORKS PHONE SYSTEM FOR THE ENGLEWOOD REGIONAL DISPATCH CENTER.**

**WHEREAS,** The Englewood Regional Dispatch Center provides police/fire/ems service to six different jurisdictions in Montgomery County, and

**WHEREAS,** the current Computer Aided Dispatch (CAD) software product is outdated, and

**WHEREAS,** the Next Generation 911 phone system is at end of life in 2021, and

**WHEREAS,** the City of Englewood wants to utilize state-of-the art technology, and

**WHEREAS,** City staff has engaged in extensive review of current operations, and

**WHEREAS,** City staff has negotiated very favorable pricing from vendors.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO AS FOLLOWS:**

**SECTION I:** That the City Manager is hereby authorized to purchase the PremierOne Suite of programs and the CallWorks Phone Next Generation 911 Phone system from Motorola solutions for a contract price not to exceed Four Hundred Fifty Thousand Dollars (\$450,000).




