A RESOLUTION: AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH CDBG AND CONTRACT WITH FIELD OF PLAY FOR THE CONSTRUCTION OF AN ADA COMPLIANT BASEBALL PLAYING SURFACE AT CENTENNIAL PARK

WHEREAS, federal criteria for Community Development Block Grant (CDBG) funds include physical improvements in compliance with the Americans with Disabilities Act (ADA); and

WHEREAS, the Montgomery County Community Development Block Grant (CDBG) has awarded the City of Englewood a grant in the amount of \$75,000 for the installation of an ADA compliant turf infield at Centennial Park; and

WHEREAS, Englewood Little League will create and maintain a Challenger Division for children with disabilities to have the opportunity to participate in baseball regardless of ability or limitations; and

WHEREAS, with the approval from CDBG, estimates for construction of the project were solicited with the lowest and best being received from Field Of Play.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, COUNTY OF MONTGOMERY, STATE OF OHIO, AS FOLLOWS:

SECTION I That the City Manager is hereby authorized to execute an agreement with Montgomery County CDBG and a contract with Field Of Play, 13875 Hall Road, Chardon, Ohio 44024 for the construction of a turf infield at Centennial Park in an amount not to exceed one hundred twelve thousand seven hundred and ninety eight dollars and no cents (\$112,798.00).

SECTION II It is hereby found and determined that all formal actions of this council concerning and relating to the passage of this resolution were taken in open meetings of this council, and that all deliberations of this council and/or any committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements.


SECTION III That this resolution shall be in full force and effect at the earliest date allowed by law.
