**RESOLUTION NO: 20-21**

**PASSED: May 25, 2021**

**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO RENEW AN AGREEMENT WITH OHIO BENEFITS COOPERATIVE TO CONTRACT WITH ANTHEM BLUE CROSS AND BLUE SHIELD TO PROVIDE A MEDICAL AND PRESCRIPTION DRUG INSURANCE PROGRAM FOR THE BENEFIT OF FULL-TIME EMPLOYEES.**

**WHEREAS**, the City of Englewood has retained the services of McGohan/Brabender, Inc. to act as broker for employee health and welfare benefits, and the City is a member of the Ohio Benefits Cooperative (OBC); and

**WHEREAS**, the OBC, being a self-insured group, has retained the services of Jefferson Health Plan (JHP) to administer the group's plan and negotiated an acceptable renewal for medical and prescription drug benefits for the benefit period beginning September 1, 2021.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO AS FOLLOWS:**

<b>SECTION I</b>	That the City Manager is hereby authorized and directed to enter into an agreement with <i>Ohio Benefits Cooperative and Anthem Blue Cross and Blue Shield</i> , to provide a medical and prescription drug program based on 69 currently participating employees, such agreement to be effective September 1, 2021 through August 31, 2022.  The estimated maximum benefit period cost, based on current participation levels, shall not exceed ONE MILLION THREE HUNDRED FORTY-SIX THOUSAND TWO HUNDRED DOLLARS (\$1,346,000.00).
<b>SECTION II</b>	It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION III

That this Resolution shall be in full force and effect at the earliest date allowed by law.
