**A RESOLUTION: APPROVING THE REPLACEMENT OF A WENGER ROAD  
WATER MAIN**

**WHEREAS**, a section of 16-inch water main that is a major feed from the water treatment plant has broken three times in recent history; and

**WHEREAS**, this main is apparently deficient and unreliable; and

**WHEREAS**, this major water artery is important to provide service to the entire community.


**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ENGLEWOOD, OHIO AS FOLLOWS:**

SECTION I	That the immediate replacement of 640 feet of water main on East Wenger Road is hereby approved for replacement.
SECTION II	That the contractors and suppliers are approved based upon the estimates provided on the attached sheet marked "Exhibit A" and made part hereof.
SECTION III	It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.
SECTION IV	That this Resolution shall be in full force and effect at the earliest date allowed by law.
