AN ORDINANCE:

**AMENDING SECTION 220.02 OF THE
ENGLEWOOD CODIFIED ORDINANCES TO
ESTABLISH PARAMETERS FOR PUBLIC
COMMENT DURING CITY COUNCIL MEETINGS**

WHEREAS, the City has enacted Section 220.02 of the Codified Ordinances of Englewood, which establishes administrative procedures for City Council meetings; and

WHEREAS, the City Council has determined that it would be in the best interests of the City to amend Section 220.02 to establish certain time limits applicable to all public comment portions of City Council meetings; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

SECTION I **Section 220.02** is hereby amended to add the following subsection (k):

(k) During any portion of any City Council meeting when public comments are being heard, each person who wishes to speak is entitled to speak for up to five (5) minutes to the City Council upon being recognized by the Mayor. The Mayor may prompt any such speaker to conclude their remarks upon reaching the time limit. Notwithstanding the foregoing, the Mayor may limit any speaker's time in the interests of order and decorum. No person may donate their speaking time to any other person.

SECTION II All provisions of Chapter 220 not specifically amended herein shall remain the same.

SECTION III It is hereby found and determined that all formal actions of this City Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and any committees that resulted in those formal actions

were in meetings open to the public, in compliance with all legal requirements.

SECTION VII That this Ordinance shall be in full force and at the earliest date allowed by law.


