**A RESOLUTION: AUTHORIZING THE SUBMITTAL OF A LAND AND WATER CONSERVATION FUND GRANT APPLICATION TO THE OHIO DEPARTMENT OF NATURAL RESOURCES**

**WHEREAS**, the State of Ohio through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through the federal Land and Water Conservation Fund, and

**WHEREAS**, the city of Englewood is desirous of utilizing the Land and Water Conservation Fund for assistance to improve Centennial Park tennis/pickleball courts and nature walking path; and

**WHEREAS**, the City of Englewood is requesting \$50,000 in Land and Water Conservation Funds to assist with improvements to Centennial Park.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, COUNTY OF MONTGOMERY, STATE OF OHIO, AS FOLLOWS:**

**SECTION I** That the City Manager be herewith authorized to act, and designated as the official representative of Englewood, in conjunction with all aspects of the preparation, filing, provision of information, and submittal of documentation necessary for participation in the Land and Water Conservation Fund Program.

**SECTION II** That City Council hereby approves filing of this application and agrees that participation in the Program will require compliance with program guidelines and assurances.

**SECTION III** That City Council hereby commits itself to provide matching funds, \$50,000 as described in the application, and authorizes the City Manager to expend those funds as necessary.

**SECTION IV** It is hereby found and determined that all formal actions of this council concerning and relating to the passage of this resolution were taken in open meetings of this council, and that all deliberations of this council and/or any committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements.


**SECTION V**


