**AN ORDINANCE: AMENDING CHAPTER 858 OF THE ENGLEWOOD, OHIO CODIFIED ORDINANCES, TITLED "HOTEL/MOTEL OPERATIONS".**

**WHEREAS**, the City has enacted Chapter 858 of the Englewood, Ohio Codified Ordinances, which is titled "Hotel/Motel Operations"; and

**WHEREAS**, the purpose of Chapter 858 is to implement comprehensive regulations governing the operation of hotels and motels within the City in a manner that will promote the health, safety, and welfare of the citizens of Englewood; and

**WHEREAS**, the City Council has determined that it would be in the best interests of the City to amend Chapter 858 of the Englewood, Ohio Codified Ordinances in order to prohibit hotels and motels from providing extended or residential stays within the City; and

**WHEREAS**, the City is authorized as a charter municipality to exercise all powers of local self-government.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I** Chapter 858 of the Englewood, Ohio Codified Ordinances is hereby amended, by the addition of **Section 858.12**, as follows:

**No hotel/motel room shall be occupied by the same occupant or occupants for more than 30 consecutive days or more than 30 days in any 45 consecutive day period, irrespective of whether such room contains independent provisions for living, eating, cooking, sleeping, and/or sanitation.**

**SECTION II** All provisions of Chapter 858 not specifically amended herein shall remain the same.

**SECTION III** It is hereby found and determined that all formal actions of this City Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION IV**

That this Ordinance shall be in full force and effect at the earliest date allowed by law.




