A RESOLUTION: AUTHORIZING THE CITY MANAGER TO PURCHASE THREE (3) POLICE EQUIPPED VEHICLES.

WHEREAS, the City of Englewood has joined with the State of Ohio Cooperative Purchasing Program; and

WHEREAS, the State has historically publicly bid police equipped vehicles and general-purpose vehicles; and

WHEREAS, Englewood City Council authorized the purchase of two police equipped vehicles on December 13, 2022 via Resolution 34-22; and

WHEREAS, the City was recently notified that our order for those two 2023 model year police equipped vehicles will likely not be fulfilled; and

WHEREAS, the City still has an essential operational need to replace police patrol vehicles on a replacement cycle that ensures the delivery of police services in the community.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO AS FOLLOWS:

SECTION I: That the City Manager is hereby authorized to purchase three (3) police equipped vehicles at a price of approximately One Hundred, Eighty-One Thousand Dollars (\$181,000) per the written quote provided by Statewide Ford, who can supply the vehicles.

SECTION II: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.

SECTION III: That this Resolution shall be in full force and effect at the earliest date allowed by law.
