**AN ORDINANCE:** **AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION TO COOPERATE IN THE BRIDGE DECK UPGRADES INCLUDING INTERSTATE ROUTE 70 AT MILE MARKER 11.303 IN THE CITY OF ENGLEWOOD (PID #114955) AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Englewood desires to fully cooperate with the Ohio Department of Transportation (ODOT) to achieve the placement of epoxy wearing surface on bridge decks including SFN 5705533 on Interstate Route 70 at mile marker 11.303 in the city; and

**WHEREAS**, the ODOT funding portion is 100% and the local share is 0%; and

**WHEREAS**, ODOT has proposed a legislative contract specifying the terms and conditions of this cooperative project;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I** That the City Manager is hereby authorized and directed to execute the attached legislative agreement, marked "Attachment A", be and made part hereof, with the Ohio Department of Transportation to accomplish the project therein described, Bridge Deck Upgrades on Interstate Route 70 at mile marker 11.303 in the City of Englewood (PID #114955).

**SECTION II** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.

**SECTION III** That this Ordinance is hereby declared to be an emergency measure for the reason that it is intended to promote highway safety and to expedite highway projects for the public health, safety and welfare. As such, this legislation shall be in full force and effect immediately upon passage.
