**A RESOLUTION: AUTHORIZING THE APPROVAL OF THE CHARGES ASSESSED  
AND COLLECTED FOR MULTI-FAMILY RESIDENTIAL  
DUMPSTER SERVICE EACH YEAR UNTIL MARCH 31, 2027**

**WHEREAS**, the City negotiated a contract extension to include the multi-family residential dumpster service at a rate increase per unit, per month effective April 1, 2024; and an additional rate increase per unit, per month effective April 1, 2025; and an additional rate increase per unit, per month effective April 1, 2026; and

**WHEREAS**, this contract will provide additional costs to the City and dumpster service rates and needs to be updated for our residents; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I** For dumpster service provided from April 1, 2024, to March 31, 2025, the monthly charges for dumpster refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Multi-family residential dumpster service, with recycling \$52.00

**SECTION II** For dumpster service provided from April 1, 2025, to March 31, 2026, the monthly charges for dumpster refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Multi-family residential dumpster service, with recycling \$56.00

**SECTION III** For dumpster service provided from April 1, 2026, to March 31, 2027, the monthly charges for dumpster refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:


Multi-family residential dumpster service, with recycling \$61.00


**SECTION V**


