**A RESOLUTION: APPROVING THE NEW RENTAL FEE SCHEDULE FOR THE EARL HECK COMMUNITY CENTER**

**WHEREAS**, individuals and groups frequently make use of the facilities at the Earl Heck Community Center for various meetings and functions; and

**WHEREAS**, there are four categories for which fees are determined; and

**WHEREAS**, the last time the fees were adjusted for rental at the Earl Heck Center was in February, 2007;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I**      The following fees shall be charged for use of the Earl Heck Community Center:

Group #1 – Local public service organizations which involve and significantly contribute to the welfare of the general public population (Local means City of Englewood residents):

Weekdays – first two hours – No Charge | Additional hours – no charge

Weekends – first two hours – \$20 per hour (minimum \$40) | Additional hours \$20 per hour

**SECTION II**      The following fees shall apply to Group #2 – Instructors, non-profit/special interest groups serving the community (Group serving the community means organization or activity predominately made up of Englewood residents and having local leadership):

Weekdays – first two hours – \$10 per hour | Additional hours – \$15 per hour

Weekends – first two hours – \$35 per hour (minimum \$70) | Additional hours \$30 per hour

**SECTION III** The following fees shall apply to Group #3 – Other non-profit groups, local religious instruction/worship (Local means City of Englewood residents):

Weekdays – first two hours – \$40 per hour | Additional hours – \$25 per hour

Weekends – first two hours – \$50 per hour (minimum \$100) | Additional hours \$35 per hour

**SECTION IV** The following fees shall apply to Group #4 – All others, including private parties and profit-making groups and individuals:

Weekdays – first two hours – \$50 per hour | Additional hours – \$25 per hour

Weekends – first two hours – \$100 per hour (\$75 for Englewood residents) (minimum \$150) | Additional hours \$50 per hour

**SECTION V** A charge of \$50 shall be assessed (deposit) when a facility is used pursuant to a permit to serve alcoholic beverages. This is a non-refundable fee in addition to any deposit required.

**SECTION VI** Any part of an hour shall be considered an extra hour.

**SECTION VII** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions, were in meetings open to the public, in compliance with all legal requirements.

**SECTION VIII** That this Resolution shall be in full force and effect at the earliest date allowed by law.
