**A RESOLUTION: APPROVING THE CHARGES ASSESSED AND COLLECTED
FOR RESIDENTIAL SOLID WASTE COLLECTON AND
DISPOSAL FOR YEARS UNTIL MARCH 31, 2027**

WHEREAS, this new rates for the 2025 and 2026 year need to be assessed and collected; and

WHEREAS, the contract with Rumpke will provide additional costs to the City and refuse rates need to be updated for our residents; and

WHEREAS, Other costs associated with the disposal of refuse in the city are projected to increase.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

SECTION I For refuse service provided from April 1, 2025, to March 30, 2026, the monthly charges for residential refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Single family residence including curbside recycling	\$17.43
Surcharge for Carryout Service	\$12.00
Surcharge for Toter Service	\$ 3.00
Multi-family residential dumpster service, with recycling	\$56.00

SECTION II For refuse service provided from April 1, 2026, to March 30, 2027, the monthly charges for residential refuse collection services as provided for in Chapter 1064, Residential Solid Waste Collection and Disposal, of the Codified Ordinances of Englewood, Ohio, are as follows:

Single family residence including curbside recycling	\$18.47
Surcharge for Carryout Service	\$12.00
Surcharge for Toter Service	\$ 3.00
Multi-family residential dumpster service, with recycling	\$61.00

SECTION III It is hereby found and determined that all formal actions of this Council concerning and relating to the Passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION IV

That this Resolution shall be in full force and effect at the earliest date allowed by law.


