**A RESOLUTION: APPROVING GOVERNMENT CENTER MEETING ROOM RATES**

**WHEREAS**, the Englewood Government Center will have new meeting rooms available soon with the addition of the North Wing; and

**WHEREAS**, the Council Chambers and the Basement will remain free of charge for all groups during weekdays; and

**WHEREAS**, to organize a charges and guidelines for the use of the facility.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, STATE OF OHIO, AS FOLLOWS:**

**SECTION I**           The following fees shall be charged for Englewood Non-Profit Organizations:

Weekdays

- No Charge

Weekends – after 5:00pm on Friday until Monday at 8:00am

- \$40 for first 2 hours and \$20 for each additional hour

**SECTION II**           The following fees shall be charged for Other Non-Profit Organizations:

Weekdays

- \$20 for first 2 hours and \$10 for each additional hour
- Council Chambers and Basement will remain free

Weekends – after 5:00pm on Friday until Monday at 8:00am

- \$70 for first 2 hours and \$20 for each additional hour

**SECTION III**           The following fees shall be charged for Event/Private Party and all other groups:

Weekdays

- \$100 for first 2 hours and \$30 for each additional hour
- Council Chambers and Basement will remain free

Weekends – after 5:00pm on Friday until Monday at 8:00am

- \$200 nonresidents for first 2 hours and \$50 for each additional hour
- \$150 for residents for first 2 hours and \$50 for each additional hour


**SECTION IV**
