**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO PURCHASE, INSTALL AND PROGRAM REPLACEMENT PUBLIC SAFETY DISPATCH RADIO CONSOLES**

**WHEREAS**, the City of Englewood operates a regional public safety dispatch center; and

**WHEREAS**, the Englewood Dispatch Center's radio communication system is connected to the State of Ohio Multi-Area Radio Communications System (MARCS); and

**WHEREAS**, the dispatch radio consoles are approaching end-of-life and require technology and cybersecurity upgrades to remain operational and a part of the MARCS system; and

**WHEREAS**, Motorola Solutions, a sole-source vendor, has provided a project proposal, including pricing, subject to the terms and conditions of the State of Ohio STS Contract 573077-0 which remains valid until April 4, 2025.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, STATE OF OHIO AS FOLLOWS:**

**SECTION I:** That the City Manager is hereby authorized to execute a contract with **Motorola Solutions, Inc., 1301 East Algonquin Road, Schaumburg, IL 60196** for the purchase of hardware, software and services necessary for the upgrade to the AXS Dispatch Consoles and DSC 8000 series site controller in an amount not to exceed two-hundred thirty thousand, two-hundred and thirty-one dollars (\$230,231.00), as the formal bidding process is waived in accordance with Section 232.10(n) of the Englewood Codified Ordinances.

**SECTION II:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.

**SECTION III:** That this Resolution shall be in full force and effect at the earliest date allowed by law.
