**A RESOLUTION: AMENDING THE PUBLIC RECORDS POLICY FOR THE  
CITY OF ENGLEWOOD, OHIO**

**WHEREAS,** the Englewood City Council passed Resolution 26-07 on August 28, 2007, adopting a Public Records Policy for the City of Englewood to comply with State law; and


**WHEREAS,** it is appropriate to review and modify such policies when necessitated by changes in State law and/or for operational efficiency; and

**WHEREAS,** the Ohio State Legislature amended R.C. §149.43 (“Public Records law”) by enacting House Bill 315 (effective April 3, 2025) which authorizes the charging of actual costs associated with the retrieving, downloading, reviewing, redacting, uploading, and producing of requested video records for public release.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ENGLEWOOD, MONTGOMERY COUNTY, STATE OF OHIO, AS FOLLOWS:**

- SECTION I:** The attached Exhibit A: Public Records Policy of the City of Englewood be adopted, replaces and supersedes the prior policy adopted by Resolution 26-07.
- SECTION II:** The Public Records Policy is incorporated as Appendix E in the City of Englewood Employment Handbook.
- SECTION III:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.
- SECTION IV:** That this Resolution shall be in full force and effect at the earliest date allowed by law.
