**A RESOLUTION: AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT TO PURCHASE, INSTALL AND PROGRAM PUBLIC SAFETY RADIOS**

**WHEREAS**, the City of Englewood's Police Department utilizes the Ohio statewide Multi-Area Radio Communication System (MARCS) to provide vital two-way radio communications between the dispatch center, police personnel and neighboring public safety agencies; and

**WHEREAS**, new mobile and portable radio technology is necessary to replace older equipment that is out of warranty and nearing end-of-life; and

**WHEREAS**, these public safety radios will provide upgraded technology that will include additional features enhancing personnel safety, location tracking, and future integrations with body-worn cameras and A.I. enhancements; and

**WHEREAS**, Motorola Solutions, a sole-source vendor, has offered discounted equipment prices through December 15, 2025, that will reduce the planned capital expense in 2026.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, STATE OF OHIO AS FOLLOWS:**

**SECTION I:** That the City Manager is hereby authorized to execute a contract with **Motorola Solutions, Inc., 1301 East Algonquin Road, Schaumburg, IL 60196**, for the purchase, installation and programming of public safety mobile radios, portable radios and all necessary appurtenances in an amount not to exceed two hundred, sixty-five thousand dollars (\$265,000).

**SECTION II:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements.

**SECTION III:** That this Resolution shall be in full force and effect at the earliest date allowed by law.
